










PROCEEDINGS OF IQAC MEETING - I


Date: 18-06-2012

2. The meeting transacted at length, different issues enlisted in the Agenda and the following resolutions were passed.

Resolved

- i. To request Prof. Shreepad Bhat to prepare the Time Table at the earliest and to arrange for smooth conductance of the classes immediately.
- ii. The respective Head of the departments are directed to immediately allot the subjects and to arrange for the commencement of classes.
- iii. All the teachers are to maintain the work diary compulsorily and 75% attendance is compulsory for the students.
- iv. To ensure discipline in the campus, the Physical Director is directed to maintain discipline among the students and to see that no classes remain unengaged. To display at prominent places, boards, banners, warning against the use of tobacco.
- v. To introduce the mentor system for different classes and each lecturer to be allotted 50 students under the mentor system. The staff are requested to maintain proper records of the grievances of the students and the measures suggested to overcome the grievances.


1. The IQAC meeting was conducted on 20-02-2013 under the chairmanship of Dr. R.G.Hegde.

Resolve











PROCEEDINGS OF IQAC MEETING
